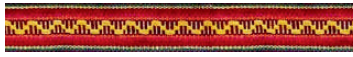

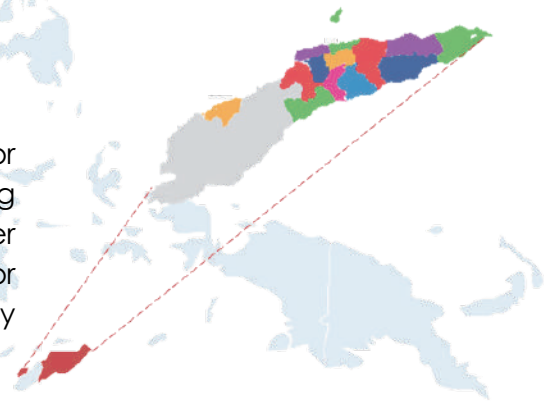
The nation's strategic location serves as a key export platform with preferential market access to over 2 billion people across 56 countries, supported by world-class port infrastructure.

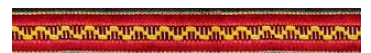
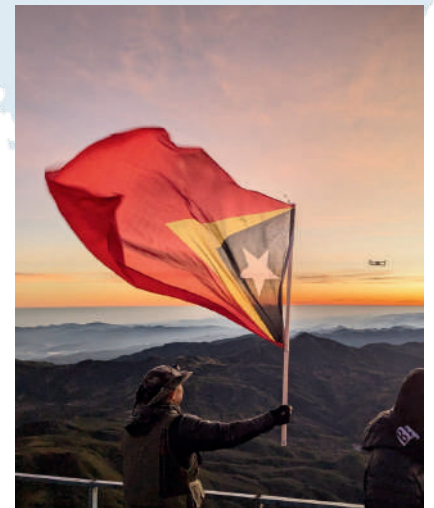
